1. Keeping people safe from vulnerable situations

- 1.1 We know that there will be times in people's lives when they require extra support and help. We will be there in those moments to ensure that appropriate and timely support is provided to manage risk and prevent any further escalation of need. We will focus our activity in the following areas:
 - Fire and Rescue Service through the Integrated Risk Management Plan (IRMP), we will prevent fire wherever possible, through fire safety checks targeted at those who need it most and wider public awareness campaigns.
 - Fire and Rescue we will continue to conduct 'safe and well' visits for people who need it most, including fitting smoke alarms and fire detection equipment free of charge.
