Early Help Redesign

Content:

Out of Scope:

- Youth Emotional Support, Pause, Domestic Abuse, Intentionally Homeless, Youth Homelessness, Young Carers, Early Years and Business Support and Performance

Review

Full review conducted looked at:

- Delivery points, footfall (volume and pattern of users)
- Group Offer and duplication in libraries and by health partners
- Evaluation of which families reached
- Impact of targeted intervention

This demonstrated:

- Centre based offer does not necessarily reach those most in need of help
- Footfall in several delivery points is very low
- Those visiting centres are mainly those who can access other universal services
- Over 70% of targeted intervention reach a successful outcome with only 3% requiring a social work intervention in the following 12 months

Proposed Changes

Enhance the targeting offer

Increase Enabling Families offer

Improve offer to schools

Cease delivering group work

Reduce delivery points 55 to 11 – focus on outreach (43 CFC/12 youth centres)

Greater alignment to Social Care starting with Integrated Front Door

Continue information, advice and guidance, Free Entitlement and Crisis support

Proposed Centres to Retain

Rational: Primarily sited in areas of highest deprivation and at least one per District and Borough. Data source Index of Multiple Deprivation 2019: overall ranking lower tier authorities in West Sussex:

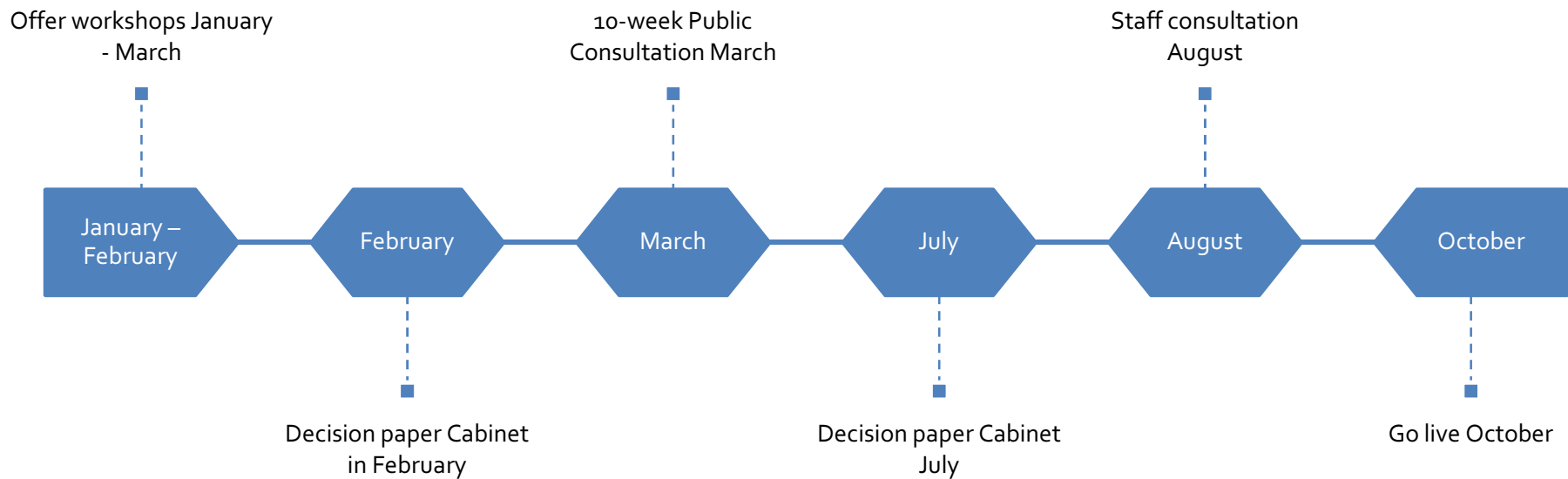


Building use opportunity – asset plan
