Introduction

- TfSE are consulting on a Draft Strategic Investment Plan
- Delivery of the Transport Strategy Vision and strategic goals
 - Economic (improved productivity and economic growth)
 - Social (improved quality of life)
 - Environment (protect and enhance the environment)
- 30 year investment plan
- Intended to bridge the gap between national and local government
- Developed using thematic & area studies and engagement with stakeholders



Draft SIP summary

- 30 regional packages of investment opportunities
- Investment priorities:
 - Decarbonisation and environment
 - Adapting to a new normal
 - Levelling up left behind communities
 - Regeneration and growth
 - World class urban transport systems
 - East-west connectivity
 - Resilient radial corridors
 - Global gateways & freight



Packages of interventions

- 6 global packages national regulatory and policy activity
 - Decarbonisation (faster trajectory)
 - Public transport fares (reversing the real terms fare increase)
 - New mobility (e-bikes etc)
 - Road user charging (replacing fuel duty)
 - Virtual access (virtual working)
 - Integration (between modes)
- 24 place-based packages of interventions
 - 8 cover the West Sussex area
 - Rail, mass transit, active travel and highways themes



Investment and Outcome Metrics

- Estimated capital cost of £45bn over 30 years
- Of which £14.8bn is in areas covering West Sussex with annual maintenance and renewal of £880m
- Key outcomes compared to 'business as usual' in 2050
 - Increase in Gross Value Added
 - Increases in population and jobs
 - Reduction in carbon emissions
 - Increases in weekday return trips by rail, mass transit and ferry
 - Reduction in weekday return car trips

Proposed Consultation Response

- The SIP is effective in coordinating a strategic approach to regional investment
- County Council officers have worked closely with TfSE & other Local Authorities and this should continue
- Road user charging is not part of current WSTP but welcome public engagement on this issue

Areas for improvement:

 Rural Transport - A stronger focus needs to be placed on the needs and delivery in rural areas



Proposed Consultation Response

Areas for improvement:

- Active Travel Urban and rural active travel schemes should be identified and managed separately as they have differing challenges and benefits
- Active Travel Ratio of maintenance and renewal costs to capital costs seems extremely high and unlikely to be affordable
- Deliverability Concerns about some elements such as A27 improvements due to a history of delivery challenges
- Interdependencies Essential to consider the interdependencies of projects in order to achieve overall objectives
