## **Question Time: 16 December 2022**

Members asked questions of members of the Cabinet. In instances where a Cabinet Member or the Leader undertook to take follow-up action, this is noted.

#### Leader

The Leader answered questions on the following matters:

The Create Growth Programme, from Cllr Albury, Cllr Kerry-Bedell and Cllr Mercer.

Skills development and the skills pipeline in the Gatwick area (Gatwick Economic Summit), from Cllr Burrett, Cllr Chowdhury and Cllr Gibson.

In relation to the rising cost of living, in response to a question from Cllr Lord about how the number of calls to the Community Hub compared to the previous six months the Cabinet Member agreed let her know. The Cabinet Member also agreed to find out the waiting times for energy support advice from Citizens Advice.

In response to a question from Cllr Greenway about whether there is an opportunity for joint working between the Community Hub and the Arun Family Centre, the Cabinet Member said he would find out.
