Summary

This report provides an update on the development of the first draft of the Sussex Shared Delivery Plan (SDP), which is how we will deliver the Sussex Integrated Health and Care Strategy, '<u>Improving Lives Together</u>' and responds to the NHS Operational Planning Guidance for 2023/2024. It predominantly focuses on Year 1 actions with a strategic vision and roadmap for years 2-5. The latter will be the area of focus for the coming months together with strengthening and iterating the totality of the draft to reflect ongoing conversations and feedback from key stakeholders.

A key stage of this is the opportunity to present the SDP in draft form to the Health and Wellbeing Board for members to consider the content to provide feedback and comment.

1 Background and context

- 1.1 This report provides an update on the development of the first draft of the Sussex Shared Delivery Plan (SDP), which is how we will deliver the Sussex Integrated Health and Care Strategy, '<u>Improving Lives Together</u>' and responds to the NHS Operational Planning Guidance for 2023/2024. It predominantly focuses on Year 1 actions with a strategic vision and roadmap for years 2-5. The latter will be the area of focus for the coming months together with strengthening and iterating the totality of the draft to reflect ongoing conversations and feedback from key stakeholders.
- 1.2 Proposed governance arrangements for delivery of the SDP from 2023/24 are included in the accompanying draft document and have been designed to make best use of resources and concentrate collective effort on key priorities which will make the biggest difference to people living and working in Sussex.
- 1.3 As a draft, it is recognised that there is significant opportunity for strengthening content and specifically, the year 2-5 delivery milestones between April and the end of June 2023, when the final draft is submitted to NHS England and subsequently published. A key stage of this is the opportunity to present the SDP in draft form to the Health and Wellbeing Board for members to consider the content to provide feedback and comment.
- 1.4 An update on the West Sussex Health and Care Partnership Plan will also be provided in presenting this report, to demonstrate how the Integrated Care Strategy and Shared Delivery Plan inform on our Place-Based Plan priorities for transformation.

2 Proposal details

2.1 The draft Shared Delivery Plan is now in circulation for comment and feedback. Local feedback will be collated by 2nd May and be used to inform further work to develop the plan into a final version for agreement. The table below sets out the governance process by which the final version of the plan will be signed off by the NHS Sussex Integrated Care Board.

3 Consultation, engagement and advice

- 3.1 National guidance made clear that in the development of the SDP, existing patient, public and workforce insight and feedback should be drawn upon to inform development of the plan. As part of the development of the Sussex Integrated Care Strategy, Improving Lives Together, our engagement approach successfully delivered direct feedback from 18,000 people, face to face and virtual workshops with 420 people, 500 interviews and direct feedback through partners, 1440 survey responses on our ambition priorities, 800 individual conversations in public engagement events and online communication that has reached more than 200,000 people.
- 3.2 In addition to the extensive engagement already drawn upon in the development of the Integrated Care Strategy, an Engagement Planning Oversight Group has been established to ensure that insight from people and communities is appropriately and satisfactorily represented in the plan. The Group will also ensure that there is an ongoing commitment to, and arrangements for, engagement with people and communities. The membership of that group includes NHS Sussex, Community Ambassadors, Healthwatch's in Sussex, Voluntary Community Sector Alliance Members and Voluntary and Community Sector representatives of inclusion groups with a focus on health inequality, and a Young Person Ambassador.
