The purpose of the Highway Infrastructure Asset Management Policy and Strategy is to support the delivery of services and to enable safe and effective roads and transport that offers choice, is convenient to use, enhances the environment, and enables economic growth.

Our priorities

West Sussex County Council recognises that an asset management approach supports the achievement of priorities set in *Our Council Plan* which is West Sussex County Council's corporate plan for 2021-2025.

The role of West Sussex's highway infrastructure assets fundamentally underpins the ability of the Council to meet its vison and strategic aims set out in the West Sussex Plan.

The Plan focuses on four priorities, all of which are underpinned by a cross-cutting theme of tackling climate change:

- Keeping people safe from vulnerable situations
- A sustainable and prosperous economy
- Helping people and communities to fulfil their potential
- Making the best use of resources

It is recognised that delivery of highway infrastructure services predominately via the priority of 'A sustainable and prosperous economy'.
