- For older peoples services commissioned in out of county residential care services, uplifts
 will follow the host authority increases. Where the current cost of placement is out of
 county and the host authority rate is higher than the current rate paid for the placement
 by West Sussex County Council, providers are able to confirm evidence of the host
 authority rate which will be used to increase the placement costs for the West Sussex
 customer.
- For older people where needs exceed those in the banded usual maximum rates, fees are agreed on an individual basis. Individually agreed rates which commenced before the 1st Jan 2024 will be increased by 4%. Individually agreed rates commencing on or after the 1st Jan 2024 will not receive an uplift.

- Short term placements for older people on a banded usual maximum rate will be automatically uplifted in line with older people residential uplifts above. Short term services on individually agreed rates will not be uplifted.
- For residential care services for customers with learning disabilities and working age physical and sensory impairment all rates are agreed on an individual basis. All agreed rates will be increased by 8%, including both in and out of county placements and all placements made up to and including the 31st March 2024.
- Enhanced rates are paid for homes within the Adults' Services Northern area and Northern Chichester (i.e. those homes listed in the West Sussex Care Guide under Midhurst, Pulborough, Billingshurst, Easebourne and West Lavington)
