### **Part I**

#### **36. Declarations of Interests**

36.1 Cllr Mark Chilton declared an interest as a member of Chichester District Council.

#### **37. Part I Minutes of the last meeting**

37.1 The Chairman asked Committee Members to agree the Part I minutes of the last meeting. The Chairman proposed an edit at minute 24.3, point a. to read that 'external trusts often employ professional pay bodies' rather than 'external trusts were professional pay bodies'. Also to correct an error at minute 27.2 where 'embers' should read 'Members'.
