Expansion works to Nyewood CE Junior School, Bognor Regis	Part I

Summary

The County Council has a statutory duty to provide sufficient school places for all children who need a place. This report seeks approval for the allocation of capital funding from the Basic Need Capital Programme to undertake an expansion project to provide a new school hall at Nyewood CE Junior School that will provide sufficient and suitable accommodation for the previous increase in pupil numbers from 75 to 90 pupils in each year group.

West Sussex Plan: Policy Impact and Context

This proposal is in accordance with the Best Start In Life Policy within the West Sussex Plan. It will ensure access to education meeting the needs of the community.

Financial Impact

This proposal will reduce the amount of unallocated Basic Need funding as shown in the table in paragraph 4.1. Extra pupils and building space will create higher revenue costs; however these will be funded by additional per pupil funding from the Government as the places created fill up.

Recommendations

The Cabinet Member for Education and Skills is asked to:-

- (1) Approve the allocation of £1.193m from the Basic Need Capital Programme to complete the design services, and to fund the construction works and the completion of a procurement process for the delivery of works at Nyewood CE Junior School as detailed in paragraphs 2.1 and 4.3.
- (2) Delegate authority to award and enter into the contract for carrying out the works detailed in the report to the Executive Director Economy, Infrastructure and Environment.

PROPOSAL

1. **Background and Context**

1.1 The County Council has a statutory duty to provide sufficient primary and secondary school places for all children who need a place. In its strategic role as commissioner of school places, the County Council must respond to changes in demand over time by increasing or removing capacity. It

discharges this duty in partnership with Diocesan authorities and other providers. In deciding the need for places it considers the capacities of existing schools and the forecast number on roll within a locality (family group of schools).

- 1.2 School places need to be available to pupils for the start of each school year, with projects planned and delivered, wherever practicable, by the summer in the relevant year. The Basic Need requirements are reviewed annually to identify the next tranches of projects and to ensure planned projects are still required following reviews of the projection data of pupil numbers.
- 1.3 In order to accommodate the rise in pupil numbers in the Bognor Regis area, in 2015 Nyewood CE Junior School was expanded to accommodate an increase from 75 pupils in each year group to 90 pupils in each year group. A new school hall is now required to complete the expansion project.
- 1.4 The project to provide a new hall at Nyewood CE Junior School will be procured utilising a two stage design and build approach via the SCAPE¹ National Minor Works Framework with the County Council's Multi-Disciplinary Consultant (MDC) providing project management and technical services.

2. Proposal Details

- 2.1 The proposal is to provide a new school hall with associated storage at Nyewood CE Junior School. This will enable the school to fully deliver all aspects of the curriculum to all pupils following its expansion in 2015 from 75 pupils in each year group to 90 pupils in each year group.
- 2.2 Construction work is anticipated to commence on site in Spring 2019 and complete early in 2020.

FACTORS TAKEN INTO ACCOUNT

3. Consultation

- 3.1 The project has been designed and agreed in full consultation and agreement with the school.
- 3.2 The project has been submitted for planning permission.
- 3.3 The details of the proposal have been shared with the local Member representing the Bersted Division.
- 3.4 The Cabinet Member for Finance and Resources has been consulted on this proposal.

4. Financial (Revenue and Capital) and Resource Implications

4.1 The table shows the phasing of Basic Need funding as per the Capital Programme approved by County Council on 15 February 2019. This shows

the overall amount of Basic Need funding available in the 5 year Capital Programme is £48.091m after the approval of the three schemes listed in the table. Any assumptions around future assumed Basic Need settlements not yet confirmed have been removed. The phasing of the Basic Need funding can be accelerated or slipped depending on the development of plans. The table below shows that an amount of acceleration will be required from 2020/21 to 2019/20 to fund the schemes requested. This will be enacted in the budget monitor and the overall amount of Basic Need funding available will not change.

- 4.2 The County Council's Multi-Disciplinary Consultant (MDC) was appointed to undertake the initial design work necessary for the production of a planning application. Kier Construction, via the SCAPE National Minor Works Framework, has also been appointed under an initial Project Order. The cost of this initial stage is £91,000 and this has been partly funded from an initial capital allocation of £42,000 approved by the Executive Director Economy, Infrastructure and Environment.
- 4.3 Robust estimates have now been sought from the MDC for completion of the works required for this project. The MDC has advised and concluded that a budget in the sum of £861,000 will be sufficient for the building works. The remaining fees required for the project manager, technical adviser, Clerk of Works, further surveys and further design services are £256,300. A further budget for ICT, loose furniture and equipment, and statutory fees is required in the sum of £75,700.

4.4 The gross budget requirement to complete the remainder of the project is therefore \pounds 1.193m funded from the Basic Need allocation.

5. Risk Assessment Implications and Mitigations

- 5.1 The County Council is under a statutory duty to secure safe and sufficient education provision within the area. This project will ensure that the County Council meets its statutory duty to provide sufficient primary school places in the locality and meets its statutory responsibility with regard to the provision of school places in safe and properly maintained buildings.
- 5.2 The delivery of the project is subject to receipt of planning permission. Preapplication meetings and public information events have been held with planners, parents and local residents to minimise the risk.

6. Other Options Considered

6.1 One alternative is not to undertake the project. This would mean that the school cannot effectively deliver all aspects of the primary curriculum.

7. Equality and Human Rights Assessment

- 7.1 The proposal has been assessed against the criteria in respect of the Equality Act 2010 and, as it would not impact on any specific pupils or identifiable groups, this section is not applicable for this decision.
- 7.2 Everyone has the right to respect for private and family life, home and correspondence under Article 8 of the Human Rights Act. The impact of any proposed changes on the right to family life will be taken into consideration. Article 2 of the First Protocol is the right to education. No person shall be denied the right to education.
