

## Summary of key changes under the Health and Care Bill (integration elements)

2	West Sussex <b>Clinical Commissioning Group (CCG)</b> is responsible for commissioning the majority of healthcare services for the population of West Sussex	<ul style="list-style-type: none"> <li>• NHS Sussex Integrated Care Board is responsible for commissioning the majority of healthcare services for the population of Sussex (1.7million people)</li> <li>• The 106 Clinical Commissioning Groups in England will no longer exist and will be replaced by 42 ICBs covering England</li> <li>• NHS England continues to commission some specialist services</li> </ul>
3	<b>West Sussex Health and Care Partnership</b> exists as an informal voluntary partnership arrangement to support and enable planning, commissioning and delivery of health, social care and public health services at a Place level	<ul style="list-style-type: none"> <li>• West Sussex Health and Care Partnership continues to operate as an informal voluntary partnership arrangement from 1<sup>st</sup> July 2022</li> <li>• In line with the new White Paper Place partnerships will need to consider and adopt by Spring 2023 more formal arrangements to support joint accountability for delivering outcomes. This will be subject to agreement by Cabinet and the decision-making bodies of the other statutory partners.</li> </ul>
4	West Sussex <b>Health and Wellbeing Board (HWB)</b> has a statutory role to provide whole system leadership for the health and wellbeing of the people of West Sussex and the development of sustainable and integrated health and care services	<ul style="list-style-type: none"> <li>• No change to the statutory role of the HWB</li> <li>• The membership will be reviewed to reflect the transition of West Sussex CCG to the NHS Sussex Integrated Care Board</li> </ul>
5	West Sussex <b>Health and Adults Scrutiny Committee (HASC)</b> has a statutory role in relation to health services and can propose ways that health services might be improved in West Sussex. The Committee does this by scrutinising the work of NHS Clinical Commissioning Groups (CCGs), NHS Trusts, and other independent providers of healthcare. This covers: <ul style="list-style-type: none"> <li>• major changes to health services</li> <li>• select reviews of health issues</li> <li>• local health services in need of improvement</li> </ul>	<ul style="list-style-type: none"> <li>• No change to the statutory role of HASC</li> <li>• The membership of HASC will be reviewed to reflect the transition of West Sussex CCG to the NHS Sussex Integrated Care Board</li> <li>• The Secretary of State will be able to intervene earlier in decisions about changes to local services.</li> </ul>
